DPPA PERMISSIBLE USE FORM

Government Agency Request for Records Containing Personal Information Obtained from Motor Vehicle Records

The Federal Driver's Privacy Protection Act (DPPA), 18 U.S.C. §§ 2721-2525, regulates access to personal information obtained from motor vehicle records. Under 18 U.S.C. § 2721(b)(1), the Dane County Sheriff's Office will make records containing personal information obtained from motor vehicle records available to Government Agency Requestors (Requester) based on the Requester's certification that the Requester is authorized to obtain and use the records. This form must be completed before records containing personal information will be released.
